





'CHAMELEON' DIAMOND

Blue and pink diamonds may be the pinnacle of fancy-colored diamond collecting and without doubt commanding stratospheric prices at auction due to their extreme rarity and flamboyant colors. However, the little-known chameleon diamond is also at the top of that pyramid. Like the tiny animal that changes color to adopt the surrounding environment, the chameleon diamond fascinates connoisseurs with its ability to temporarily change color after a prolonged storage in the dark or being heated to 150°C, known as the photochromic and thermochromic behavior patterns. The 'classic' chameleon would shift from an olive green color to intense brownish or orangy yellow to yellow color. Contrarily, the 'reserve' chameleon diamond acts the exact opposite to the 'classic' chameleon diamond, from yellow to green color. After exposure to light or cooling down from the heat, the chameleon would gradually revert to its original color. The reason for its ephemeral phenomenon remains a mystery to gemologists and scientists. As they are so rare and valuable, researchers have found it difficult to procure samples to study. "I wanted to cover women in constellations of stars. Stars! Stars of all sizes" – Gabrielle "Coco" Chanel

The "Bijoux de Diamants" collection was launched in November 1932, in the magnificent Parisian mansion on 29 Faubourg Saint-Honoré where Chanel was residing at the time. The collection of 35 pieces was inspired by Chanel's fascination with constellations and astrology. The motifs of stars, comets and sun she employed in her first and only fine jewelry collection were a mirror image of the night sky mosaics on the floor of the orphanage that she stayed in as a child. Originally, Chanel was famous for her bold and avantgarde costume jewelry, combining real gemstones with fake ones. She once said "I started creating costume jewelry because I felt it was refreshingly free of arrogance, during a period that tended towards ostentatious displays of luxury."

The momentous turning point for Chanel was the Great Depression when she decided to trove the gloomy climate with a dazzle of diamonds. She believed in such a devastating time, one's instinctive desire for authenticity would be reawakened in every domain. Her prophecy was indeed correct, the collection caught great attention, attracting thousands of visitors who flocked to see the spectacular jewelry collection, including princesses, duchesses and ambassadors. Since 1932 the "Bijoux de Diamants" has been revived numerous times and is now known as the "Comète" collection.



Hammer Price is the highest bid accepted by the auctioneer by the fall of the hammer, (in the case of wine, as apportioned pro-rata by reference to the number of separately identified items in that lot), or in the case of a post-auction sale, the agreed sale price;

Purchase Price is the Hammer Price and applicable Buyer's Premium;

Reserve is the (confidential) minimum Hammer Price at which the Seller has agreed to sell a lot;

Seller is the person offering a lot for sale (including their agent (other than Luxeford), executors or personal representatives);
